Our Reference: - “REACH” Policy Statement.

We are writing in regard to our implementation of the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) regulation (EC) No 1907/2006. As a European materials supplier DURUM Verschleiss-Schutz GmbH acknowledges it has responsibilities relating to this regulation, we have identified our duties as below:

1. DURUM Verschleiss-Schutz GmbH recognises our duty to ensure that all relevant raw materials supplies (metals & substances) purchased by DURUM Verschleiss-Schutz GmbH are registered with the European Chemical Agency (ECHA).
2. DURUM Verschleiss-Schutz GmbH metal alloy products are exempted from REACH registration under REACH guidance notes 6.3.1, as only base metals (our raw materials) require to be registered.
3. All other non metal substances that DURUM Verschleiss-Schutz GmbH produces shall be internally reviewed for REACH compliance, where necessary these shall be submitted to ECHA for registration.
4. DURUM Verschleiss-Schutz GmbH shall continually shall risk assess metals, alloys & substances used and communicate safety information both upstream and downstream (Customers & Suppliers)
5. DURUM Verschleiss-Schutz GmbH shall communicate the safety information using Safety Data Sheets (SDS), and the appropriate Chemicals (Hazard Information and Packaging for Supply) Regulation (CHIP/CLAP) signage.
6. DURUM Verschleiss-Schutz GmbH shall continually monitor and update our SDS data sheets and our CHIP signage as appropriate to any future material and legislation changes and communicate these changes to our suppliers customers.



As our metal alloys are not direct REACH listed substances there is no pre-registration requirement for these products, Our purchase contract terms require that all metal and substance suppliers to DURUM Verschleiss-Schutz GmbH include (where relevant) any REACH registration requirements.
